## MINUTES UNIFIED SCHOOL DISTRICT #326 – LOGAN MONDAY, October 14, 2013

Logan Unified School District #326 Board of Education, met in regular session to conduct school business. **CALL TO ORDER:** Colby Greving, President, called the meeting to order at 8:00 p.m.

**CONSENT AGENDA:** Colby Greving requested the addition of the fire alarm bid of \$19,980 be added to the September minutes. Lynette Stockman requested the appointing of a member of the board to the Tech Committee be added to the agenda. Jeff Hofaker moved and Chris Delimont seconded the consent agenda as corrected, including the addition to the minutes and agenda, approval of purchase orders and approval of warrants. Motion carried 6-0.

**PRINCIPAL'S REPORT:** Mr. Adams principal's report included: light pole bids for the football field. Phil Gottstine made a motion to replace the 4 poles at existing locations, update junction boxes and wiring to code and replace bulbs. Lynette Stockman seconded. Motion carried 6-0. **SUPERINTENDENT'S REPORT:** Mr. Gower reported on the September 20 enrollment figures, the KLN grant, insurance wellness program and possible replacement of a mower. Additional items discussed were: Capital Outlay projects including installation of thermostats in the high school classrooms, welding shop upgrades, improvement of high school bathrooms, and boiler. Jeff Hofaker made a motion to spend approximately \$1,500 to install lighting in the welding cubicles. Phil Gottstine seconded. Motion carried 6-0. Chris Delimont moved to accept the resolution from First National Bank & Trust in regards to bank authorizations. Jeff Hofaker seconded. Motion carried 6-0. Lynette Stockman made a motion to appoint Ryan Grammon as the board representative to the Tech Committee. Chris Delimont seconded. Motion carried 6-0.

**NCKSEC REPORT:** Jeff Hofaker reported on the recent meeting that included discussion of the continual turnover of Paras and awards received.

Motion carried 6-0. Mr. Gower and Mr. Adams were asked to attend the session.

The board reconvened at 10:30 p.m. A motion to return to executive session for a period of an additional 10 minutes at 10:40 p.m. to discuss personnel to protect the privacy interests of the individual(s) to be discussed was made by Jeff Hofaker seconded by Lynette Stockman. Motion carried 6-0. Mr. Gower and Mr. Adams were asked to attend the session.
